

# Tony Grampsas Youth Services Program - Grants For The Prevention Of Youth Marijuana Use

### **Program Overview**

**Summary:** Tony Grampsas Youth Services (TGYS) is a state-administered grant program within the Colorado Department of Human Services (CDHS). TGYS provides funding for local prevention, intervention, and education programs for youth and their families in Colorado. TGYS typical provides funding for over 100 programs a year across Colorado with the shared goal of preventing youth crime and violence, marijuana use, and child abuse and neglect. TGYS operates on a three-year grant cycle. The current grant cycle runs from July 1, 2020, through June 30, 2023.


### **Oversight**

The TGYS Governing Board includes 13 members and oversees the TGYS Program. The Board reviews grant requests, selects grantee programs, and determines the amount of funding for each grantee. Funding recommendations determined by the Board are sent to the governor for final approval. No more than seven of the appointed members may be from the same political party.

### History

TGYS was established in 1994 under the Romer administration to provide state funding for community-based programs to prevent youth crime and violence. TGYS was originally titled "Youth Crime Prevention and Positive Intervention Programs" and housed within the Colorado Department of Local Affairs. TGYS was renamed after Tony Grampsas - the former Colorado legislator, member of the Joint Budget Committee and Speaker Pro Tempore of the House, and original sponsor of H.B. 94-1360 - following his passing in 1998. TGYS was eliminated in the first round of 2002 budget cuts during the Owens administration. Governor Owens reversed the budget cut 18-months later and restored funding for TGYS in 2003 following public pushback. Since then, the program has expanded beyond youth crime and violence and now includes programs that prevent child abuse and neglect, youth marijuana use, and high school dropout. In 2013, H.B. 13-1117 transferred TGYS to the Colorado Department of Human Services.
